Under the provisions of para. (3) art. 6 of the Law nr. 235 from 1st December 2011 about accreditation and conformity assessment activities (Monitorul Oficial of Republic of Moldova, 2012, nr. 46-47, art. 136),

ORDER:

- 1. To approve the List of reference standards which establish riteria for the competence of national accreditation body and conformity assessment bodies (according the annex). 2. To abrogate the Order of Ministry of Economy nr. 22 from 15.02.2016 regarding the approving of the List of reference standards which establish riteria for the competence of national accreditation body and conformity assessment bodies (Monitorul Oficial, 2016, nr.44-48 art. Nr. 345) and nr.119 from 14.06.2016 regarding the amendment of Annex of the Order nr.22 from 15.02.2016 (Monitorul Oficial, 2016, nr.184-192, art. Nr. 1111). 3.The national accreditation body and conformity assessment bodies shall be guided in their work and will meet the requirements of the applicable reference standards.
